RESOLUTION OF THE BOARD OF DIRECTORS OF THE TRACY RURAL COUNTY FIRE PROTECTION DISTRICT ADOPTING A POLICY PURSUANT TO CALIFORNIA GOVERNMENT CODE § 54956.96 (2020) TO RECEIVE AND CONSIDER IN CLOSED SESSION INFORMATION FROM SOUTH SAN JOAQUIN COUNTY FIRE AUTHORITY CLOSED SESSIONS

WHEREAS, Government Code Section 54956.96 authorizes a legislative body such as a joint powers agency to adopt a policy that authorizes the sharing of information discussed and/or considered in closed session to be disclosed to its member agencies, in specified circumstances; and

WHEREAS, the policy would allow a joint powers agency to disclose information that has direct financial or liability implications to its member agencies; and may disclose that information to its member agency's legal counsel, and to the other members of the member agency's legislative body in closed session; and

WHEREAS, upon adoption of such policy, the member agency's legislative body may conduct a closed session, on advice of legal counsel, to receive, discuss and take action on information obtained from the joint powers agency closed session; and

WHEREAS, South San Joaquin County Fire Authority has established a policy pursuant to Section 54956.96 to allow for the sharing of information with its member agencies, and their legal counsel, in those situations where there are direct financial or liability implications for the member agencies and that authorizes the legislative body of a member agency, on advice of legal counsel to conduct a closed session of the member agency's legislative body to receive, discuss and take action on information obtained from South San Joaquin County Fire Authority's closed session.

NOW THEREFORE, BE IT RESOLVED, by the Board of Directors of Tracy Rural County Fire Protection District that:

The District does hereby adopts the Closed Session Policy Pursuant to Government Code Section 54946.96

Section 1. Tracy Rural's board members serving on the board of SSJCFA may receive and relay to the full board of Tracy Rural such information obtained in a SSJCFA closed session meeting that has direct financial or liability implications for Tracy Rural as determined by Tracy Rural's legal counsel with the Clerk of the Board including such determination in the notice of closed session of the directors of Tracy Rural.

It is recommended the Board of Directors discuss the proposed sale of surplus property located at 7700 W. Linne Road, Tracy, CA 95304.

BACKGROUND

The Board of Directors have concluded that two decommissioned fire stations are owned by and are under the control of the Tracy Rural County Fire Protection District may constitute surplus land eligible for disposition under California's statutory procedures. It is recommended that the Board of Directors begin the process of designating Stations 95 – Linne Road property and 93 – Banta Property as surplus land and sell these properties to a local public agency or other purchaser.

DISCUSSION

- 6. The District must notify the appropriate planning agency to determine the sale of lease, if applicable.
- 7. Receive and consider bids. Each recipient has 60 calendar days from the date of receipt to notify the District of its intention to purchase or lease the surplus property.
- 8. If Board of Directors agrees to proceed with the sale or lease to a particular public agency, the Board of Directors must enter into a good faith negotiations for a mutual agreement on the terms of the sale or lease for a period of at least 90 calendar days, pursuant to the Government Code.
- 9. If the Board of Directors receive no bids, the District may sell or lease the surplus property by whatever method the Board of Directors determines is in the best interest of the District.

The original logo has been located but is currently in patch form. The original creator of the logo is unknown and the District is not in possession of the original file. Staff has researched many different designers to re-create the original logo. A local company was contacted and was able to re-create and update the logo and the District has all rights to the logo and all digital files of the logo, which will be used for the website, legal documents and District apparel.

On April 13, 2021, the Directors approved to support research the cost of District apparel. The same company will be able to customize apparel with the approved logo design.

FISCAL IMPACTS

The fiscal impact is \$50.00 for the logo design and \$18.00 - \$40.00 for custom apparel.
